Address by the chairman, Mr. Suresh Ellawala

Quote:

My fellow board and association members it is my pleasure as your Chairman to speak a few words on this occasion of the 39th Annual General Meeting of the LFVPPEA which is being held as a virtual meeting for the first time. We are all going through one of the most difficult periods of our lives while our sector is within what is considered essential, the challenges business face is very substantial, very high air cargo charges and the halting of air travel has impacted both our markets and our ability to supply them. Further, lockdowns have restricted our day to day operations and the supply chain. This has resulted in a drop in exports to our sector. We have to keep our heads above the water and persist hoping that the inevitable improvement in the market condition will come sooner rather than later.

At times of crisis and association has two important roles to play. The first is to be a common quorum who which representation can be made on industry issues, the other an equally important role is to provide assistance and guidance to our members and how to address some of the challenges they face. LFVPPEA has been proactive on both. And the both above mentioned areas and I thank all board members and secretariat staff for their untiring efforts during this period. Throughout the period of the pandemic your board members have participated at various meetings at the presidential secretariat, COVID task force, Airport and Aviation Authority, SLEDB and the Ministry of Agriculture. Our participation at these meetings have enabled industry opinion to be heard. And I thank the members of our board who have taken time on from their busy schedule to represent us.

I would also like to thank the EDB who is our first port of call in times of distress for facilitating our participation at many of these meetings. They have also been proactive in finding solutions to our problems, a few of our board members including myself are members of EDB advisory committee on food and beverage and this two remains an important quorum to discuss industry related issues. We have also made every effort to communicate all relevant and important news and information to our members through emails and our WhatsApp group. I believe the WhatsApp group itself has been a good addition to our communication channel and most of our members have been actively using it while the last year has been a more a period of firefighting.

I would like to highlight a few of the other areas in which the association has been able to move programs forward. You may read all of what we have done in our annual report if you haven't done already and I'm happy to say that the association was able to sign an MOU with the National Agri BIZ Council and establish the LFVPPEA secretariat. We now have a manager representing the association and following up on matters of importance. We hope our secretariat will grow to play a larger role on behalf of the association in the future. Prior to the onset of the COVID restrictions we were able to arrange a visit to the Makandura organic research station which provided an opportunity for our members to obtain knowledge on organic cultivation practices. With the increased attention being paid to the importance of a healthy life style and diet, organically grown food is a key growth area and will provide opportunity for our members to do business in a niche market, it's the higher value niche market.

Your board has also developed a 3 fruit strategy to double sector exports by 2025. The three fruits being Pineapple, Banana and Mango. Presentations were made to both the EDB and the state minister of agriculture. The strategy has received positive feedback and with the World Bank agriculture sector modernization project proposing the signing of an MOU between them and the association to take the strategy forward. Under the strategy we hope to see the expansion of both Cavendish and local small banana varieties along with the introduction of MB2 variety of pineapple. The ongoing expansion of TOMJC mango is also expected to continue. Our strategy also proposes the establishment of farmer clusters with commercial nuclear farms working alongside the smaller growers. The nucleus farms will play a role to increase the availability of export quality produce, disseminate knowledge and provide inputs to farmers. The agriculture sector modernization project will also play a very important role in disseminating knowledge and also supporting farmers with inputs. The MOU is still under discussion and we expect to sign it soon will boost the participation of our members in the ASMP in fact Mr. Hashim represented the association at a discussion yesterday with the minister of agriculture and the officials and we expect them to come back with the finalized MOU early next week so that we can circulate it.

Our goal is for Sri Lanka to gain recognition in international markets with preferred suppliers to these three fruits in a similar manner how we have gone for tea, rubber, coconut and spices. While we have seen a decline of fresh fruits and vegetables this year the processed sector has been more resilient while consumers are choosing to eat healthier and nutritious food such as fruits and vegetables.

They have also sought the convenience of products that can be stored at home for a length of time as such the demand for canned, dried and frozen products have seen improvement. This two has an important trend and opportunity for us. The dried fruit project initiated by the association through the IBC with the Noberasco Company of Italy is progressing all being slowly. The ambassador of Italy to Sri Lanka has also being touch with the Noberasco Company and embassy is keen to pursue their future investment in Sri Lanka. Once travel conditions revert to normal we expect to visit Mr. Benin Noberasco and his team to Sri Lanka and further expansion of the project. The pandemic period has exposed our sectors over dependence on air freight.

As an initiative to help our members to transition to exporting by sea our association joint together with the EU TMAP program to provide guidance on requirement for shipping perishable cargo by sea. The program is ongoing and I encourage all our members to avail themselves of the opportunity to participate in this program. There's a very knowledgeable south African Consultant who is available anytime on zoom and it would be beneficial to many members even if they are not going to utilize knowledge base right now to have a chat with them and know how do this knowledge can be utilized in their business. In order for members to gain most out of the program it has been suggested that the association website we upgraded with the member's section library. The library will store useful industry related information that members can access when required. I would also like to thank the European Union and the TAMAP being for responding positively to our request and supporting the industry though many other activities are on the drawing board including our regular seminar and a study tour to Thailand. The restrictions placed upon us by the pandemic has not permitted us to move forward with them. I hope we will be able to achieve all these and more in 2021. Because being the tradition of this association to conduct elections every two years and it has been continued this year as well.

I thank my fellow office bearers and board members for their contribution and active participation during the past year. I would also like to express my appreciation of the guidance and support extended by our senior members and past chairs. I also thank our secretariat staff and the Ceylon Chamber of Commerce for their professional assistance to us. They had been available to us 24/7 and this is greatly appreciated. I look forward to their continued assistance during the coming year. Mr. Imdhad Marikkar who is our VC2 has tendered his resignation from his executive post as he is leaving Expo Lanka. We thank him for the support and leadership given to the association during the past year. We take this opportunity to wish him well in his future endeavors. We also welcome Mr. Jagath Pathirana who is here today representing Expo Lanka. Before we move on to other matters in the agenda I would once more like to thank for their participation and wish everyone the best of health.
